WAC 220-47-42800K Beach seine – Open periods.

Notwithstanding the provisions of WAC 220-47-428, effective immediately until further notice, it is unlawful to take, fish for, or possess salmon taken for commercial purposes in Puget Sound Salmon Management and Catch Reporting Areas except in the area and during the times listed below. Unless otherwise amended, all permanent rules remain in effect.
