WAC 220-56-36000Q Razor clams – Areas and Seasons.

Notwithstanding the provisions of WAC 220-56-360, it is unlawful to dig for or possess razor clams taken for personal use from any beach in Razor Clam Areas 1, 3, 4, or 5, except as provided in this section:

- (1) Effective 12:01 p.m. October 22 through 11:59 p.m. October 28, 2014, razor clam digging is permissible in Razor Clam Area 1. Digging for razor clams is permissible from 12:01 p.m. to 11:59 p.m. each day only.
- (2) Effective 12:01 p.m. October 22 through 11:59 p.m. October 28, 2014, razor clam digging is permissible in Razor Clam Area 3. Digging for razor clams is permissible from 12:01 p.m. to 11:59 p.m. each day only.
- (3) Effective 12:01 p.m. October 25 through 11:59 p.m. October 25, 2014, razor clam digging is permissible in Razor Clam Area 4. Digging for razor clams is permissible from 12:01 p.m. to 11:59 p.m. each day only.
- (4) Effective 12:01 p.m. October 24 through 11:59 p.m. October 26, 2014, razor clam digging is permissible in Razor Clam Area 5. Digging for razor clams is permissible from 12:01 p.m. to 11:59 p.m. each day only.
- (5) It is unlawful to dig for razor clams at any time in Long Beach, Twin Harbors Beach or Copalis Beach Clam sanctuaries, as defined in WAC 220-56-372.

REPEALER

The following section of the Washington Administrative Code is repealed effective 12:01 a.m. October 29, 2014:

WAC 220-56-36000Q Razor Clams – Areas and Seasons.
