NEW SECTION

**WAC 220-310-19500G Freshwater exceptions to statewide rules—Eastside.**

Notwithstanding the provisions of WAC 220-310-195, effective November 1 through December 31, 2014, it is permissible to fish in waters of Spring Lake and Blue Lake (Columbia Co.). Unless otherwise amended, all permanent rules remain in effect.
