- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal year 2009, 2010, 2011, 2012, or 2013, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: This rule change is necessary to ensure a successful kid's fishing event. Several thousand rainbow trout will be stocked in South Lewis County Park Pond two days prior to the event to acclimate them to assure they will bite while the kids are fishing. During the event, only registered kids will be allowed to fish. There is insufficient time to adopt permanent rules.

NEW SECTION

**WAC 220-310-18500T Exceptions to statewide rules—South Lewis County Park Pond.**

Notwithstanding the provisions of WAC 220-310-185, effective 12:01 a.m. May 14 through 2:00 p.m. May 16, 2015, it is unlawful to fish in South Lewis County Park Pond, except as provided in the sections below:

- (1) Open to fishing 8:00 a.m. to 1:00 p.m. May 16, 2015, by juvenile anglers participating in the kids fishing event.
- (2) Daily limit of 5 fish.

REPEALER

The following section of the Washington Administrative Code is repealed effective 2:00 p.m. May 16, 2015:
