Under RCW 34.05.350 the agency for good cause finds:

Reasons for this finding: The forecast run size for Wallace River Hatchery Chinook is below broodstock needs. Hatchery returns will be closely monitored and if early returns indicate that the run size will meet broodstock needs the Skykomish mark selective fishery will open. There is insufficient time to adopt permanent rules.

NEW SECTION

**WAC 220-310-19000T Freshwater exceptions to statewide rules—Skykomish River.**

Notwithstanding the provisions of WAC 220-310-190, effective June 1 through July 31, 2015, it is unlawful to fish for Chinook salmon in the waters of the Skykomish River from the mouth upstream to the mouth of Wallace River.

REPEALER

The following section of the Washington Administrative Code is repealed effective August 1, 2015:
