- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal year 2009, 2010, 2011, 2012, or 2013, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: There is not enough non-treaty chum share remaining in hood canal for a purse seine opening. This creates uncertainty about purse seine effort and catches in South Sound. A reduction in openings is needed to avoid exceeding the non-treaty share of South Sound chum. There is insufficient time to adopt permanent rules.

NEW SECTION

WAC 220-47-31100U Purse seine – Open periods.

Notwithstanding the provisions of WAC 220-47-311, effective November 11, 2015, it is unlawful to fish for, or possess salmon taken for commercial purposes with purse seine in Puget Sound Salmon Management and Catch Reporting Areas 10 and 11.

WAC 220-47-41100P Gillnet – Open periods.

Notwithstanding the provisions of WAC 220-47-411, effective immediately until further notice, it is permissible to take, fish for, or possess salmon taken with gillnet gear for commercial purposes from the following designated Puget Sound Salmon Management and Catch Reporting Areas during the times indicated below and with the minimum mesh size indicated below. Unless otherwise amended, all permanent rules remain in effect.
