- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal year 2009, 2010, 2011, 2012, or 2013, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

**Reasons for this finding:** There is a harvestable surplus of chum remaining in Hood Canal and there is not enough non-treaty share in Areas 10 and 11 for a commercial purse seine opening. There is insufficient time to adopt permanent rules.

- (1) Areas 10, 11, 12B and 12C are closed on November 17, 2015
- (2) Areas 12B and 12C are open November 18, 2015 from 7 AM to 5 PM
