**EMERGENCY RULE**

Under RCW 34.05.350 the agency for good cause finds:

- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal year 2009, 2010, 2011, 2012, or 2013, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: This emergency rule is needed to close salmon fishing in Marine Area 10 as encounters have exceeded preseason expectations and to ensure compliance with conservation objectives and agreed-to management plans. There is insufficient time to adopt permanent rules.

NEW SECTION

**WAC 232-28-62100V Puget Sound salmon —saltwater seasons and daily limits.**

Notwithstanding the provisions of WAC 232-28-621, effective December 1, 2015 through January 31, 2016, it is unlawful to fish for salmon in waters of Marine Area 10, excluding year-round piers.

REPEALERS

The following section of the Washington Administrative Code is repealed effective December 1, 2015:

WAC 232-28-62100T Puget Sound salmon—saltwater seasons and daily limits. (15-402)

The following section of the Washington Administrative Code is repealed effective February 1, 2016:

WAC 232-28-621000V Puget Sound salmon—saltwater seasons and daily limits.

**EMERGENCY RULE ONLY**

Under RCW 34.05.350 the agency for good cause finds:

(x) That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.

( ) That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.

( ) That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal years 2009, 2010, 2011, 2012 or 2013 which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

**Reasons for this finding:** Encounters have exceeded preseason expectations. This regulation closes salmon fishing in Area 10 to ensure compliance with conservation objectives and agreed-to management plans. There is insufficient time to adopt permanent rules.
