ORDER NO. 15-444

NEW SECTION

WAC 220-310-19000U Freshwater exceptions to statewide rules—Puget Sound.

Notwithstanding the provisions of WAC 220-310-190, effective 7:00 a.m. December 17, 2015, through 5:00 p.m. January 14, 2016, it is permissible to fish in waters of Tokul Creek from the Fish Hatchery Road Bridge upstream to the posted cable boundary marker below the hatchery intake. Unless otherwise amended all permanent rules remain in effect.

REPEALER

The following section of the Washington Administrative Code is repealed effective January 15, 2016:

WAC 220-310-19000U Freshwater exceptions to statewide rules—Puget Sound.

EMERGENCY RULE ONLY

Under RCW 34.05.350 the agency for good cause finds:
