### WAC 220-312-05000A Freshwater exceptions to statewide rules—Eastside.

Notwithstanding the provisions of WAC 220-312-050, effective April 1 through May 31, 2017, in those waters of the Klickitat River from the mouth (Burlington Northern Railroad Bridge) to Fisher Hill Bridge fishing is only allowed Mondays, Wednesdays and Saturdays.
