## NEW SECTION

## WAC 220-312-05000E Freshwater exceptions to statewide rules—Eastside.

Notwithstanding the provisions of WAC 220-312-050, it is unlawful to fish in Frank's Pond (Chelan Co.) except as provided in this section:

- (1) Open to juvenile anglers only April 22 through August 19, 2017.
- (2) Night closure is in effect.
- (3) Daily limit of 2 trout no size restrictions.
- (4) All other game fish, daily limit 5 no size restrictions.
