Reasons for this finding: This emergency rule is needed to extend the trout fishery in South Pond at the Bogachiel
Hatchery because recent restrictions to the public access to Wentworth Lake, hatchery trout normally planted into
Wentworth Lake are being planted in the South Pond which will provide additional angling opportunity. The
agency is considering making this fishery a permanent rule.

## WAC 220-312-02000J Freshwater exceptions to statewide rules—Coastal.

Notwithstanding the provisions of WAC 220-312-020, effective August 26, 2017 until further notice, it is permissible to fish in those waters of South Pond at the Bogachiel Hatchery.
