WAC 220-356-20000A Puget Sound smelt commercial fishery—Weekly periods.

Notwithstanding the provisions of WAC 220-356-200, effective immediately until further notice, it is permissible to fish for smelt for commercial purposes in Puget Sound Marine Fish-Shellfish Management and Catch Reporting Area 22A seven days per week.
