**EMERGENCY RULE**

Under RCW 34.05.350 the agency for good cause finds:

- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.

**Reasons for this finding:** This emergency rule is needed to close the commercial salmon fisheries in Salmon Management and Catch Reporting Areas 12, 12B, and 12C as the non-treaty share at the current in-season run size has been harvested. Additionally, in Salmon Management and Catch Reporting Areas 10 and 11 the purse seine schedule has been adjusted per in-season discussions with the co-managers. There is insufficient time to adopt permanent rules.
