EMERGENCY RULE

Reasons for this finding: This emergency rule is needed to close the commercial salmon fisheries in Salmon Management and Catch Reporting Areas 12, 12B and 12C as the non-treaty share has been harvested under the current co-manager agreed to in-season run-size. There is insufficient time to adopt permanent rules.


