Reasons for this finding: This emergency rule is needed because coho broodstock needs at the Sol Duc Hatchery have been met, and surplus hatchery (adipose fin clipped) coho remain in the Sol Duc River below the hatchery. This action allows anglers to retain hatchery coho through December 15th. There is insufficient time to adopt permanent rules.
