EMERGENCY RULE

Under RCW 34.05.350 the agency for good cause finds:

- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.

Reasons for this finding: This emergency rule is needed because low numbers of hatchery summer steelhead are expected to return to the Green River in 2018. This rule will protect returning adult hatchery summer steelhead and increase the likelihood of achieving broodstock collection goals this summer. There is insufficient time to adopt permanent rules.

NEW SECTION

WAC 220-312-04000L Freshwater exceptions to statewide rules—Puget Sound.

Notwithstanding the provisions of WAC 220-312-040, effective June 2, 2018 until further notice:

Green (Duwamish) River (King County): from an east-west line extending through the southernmost tip of Harbor Island to the water pipeline walk bridge (1/2 mile downstream of Tacoma Headworks Dam); it is unlawful to retain steelhead.
