

WAC 220-312-04000Q Freshwater exceptions to statewide rules—Puget Sound.

Notwithstanding the provisions of WAC 220-312-040, it is unlawful to violate the following provisions, effective immediately:

Ross Lake tributaries and their tributaries (except Ruby and Big Beaver Creeks)
(Whatcom Co.): from mouths upstream 1 mile: Closed waters.
