WAC 220-415-13000C Mountain goat seasons and permit quotas.

Notwithstanding the provisions of WAC 220-415-130, effective immediately, until further notice, the following rules apply:

- (1) Due to the recent forest fires, the U.S. Forest Service has closed access to most of the East Olympic Mountains (6-1) mountain goat hunt. This closure will likely remain in effect for most of the 2018 hunting season.
- (2) This rule extends the season for both hunts 6012 (East Olympic Mountains A) and 6013 (East Olympic Mountain B) both in area 6-1 to November 30, 2018, allowing permit holders who have not yet harvested to continue hunting where legal access is provided.
