EMERGENCY RULE

Under RCW 34.05.350 the agency for good cause finds:

Reasons for this finding: This emergency rule is necessary to close Dungeness River fisheries downstream of the Gray Wolf River at Dungeness Forks Campground. Currently the number of coho which have returned to the Dungeness River is below pre-season expectation. To help ensure escapement needs are met the river will close to angling until further notice. There is insufficient time to adopt permanent rules.
