EMERGENCY RULE

Under RCW 34.05.350 the agency for good cause finds:

- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.

Reasons for this finding: This rule is needed to close white sturgeon retention in The Dalles Pool. Current harvest rates indicate this measure is necessary in order to stay within the 135 sturgeon harvest quota. This action is consistent with decisions made by the States of Washington and Oregon on January 4, 2019. There is insufficient time to adopt permanent regulations.
