EMERGENCY RULE

Reasons for this finding: This emergency rule is needed to open Langlois Lake for one day of fishing to provide angling opportunity for Project Healing Waters which is dedicated to the physical and emotional rehabilitation of disabled active military service personnel and disabled veterans through fishing. There is insufficient time to adopt permanent rules.

NEW SECTION

WAC 220-312-04000J Freshwater exceptions to statewide rules—Langlois Lake.

Notwithstanding the provisions of WAC 220-312-040, effective one hour before official sunrise to one hour after official sunset on April 20, 2019, it is permissible for anglers participating in the Project Healing Waters fishing event to fish in the waters of Langlois Lake. Statewide size and daily limits apply.
