WAC 220-312-06000G Freshwater exceptions to statewide rules—Columbia Notwithstanding the provisions of WAC 220-312-060, effective March 1, 2020 until further notice:

From the mouth to Hwy. 730 at the Washington/Oregon Border: It is unlawful to use barbed hooks when fishing for salmon or steelhead.
