NEW SECTION

WAC 220-312-050001 Freshwater exceptions to statewide rules—Eastside.

Effective September 11 through October 11, 2020 the following provisions of WAC 220-312-050 regarding gamefish seasons for Hatch and McDowell lakes shall be as described below. All other provisions of WAC 220-312-050 not addressed herein, or otherwise amended by emergency rule, remain in effect:

(1) Hatch Lake (Stevens County): Gamefish: No daily limit. No size restrictions.

(2) McDowell (Stevens County): Gamefish:

- (a) No Daily limit. No size restrictions.
- (b) Conventional fishing gear is allowed.
