Purpose: The purpose of this emergency rule is close commercial gillnet and purse seine fisheries in Salmon Management and Catch Reporting Areas 10, 11, 12, and 12B for opening scheduled between October 13 and October 15, 2020. This rule also corrects a preseason scheduling mistake by closing fisheries in 7 and 7A on October 10, 2020.

Reasons for this finding: This emergency rule is needed to adjust commercial gillnet and purse seine salmon fisheries in Puget Sound Salmon Management and Catch Reporting Areas 10, 11 12, 12B. This rule also closes commercial gillnet and purse seine fisheries scheduled for October 10, 2020 in Areas 7 and 7A to

2020 pre-season forecasts for chum salmon returning to Puget Sound are lower than in the recent past. The 2019 return of fall chum salmon was much lower than forecast and many places did not reach spawning escapement goals. Fishery openings planned in Area 10 and 11 are contingent on a test fishery based run-size update that predicts sufficient harvestable surplus, and in-season agreement from Tribal Co-managers as agreed to in the 2020-21 List of Agreed to Fisheries (LOAF). The Areas 12 and 12B Chum fishery was scheduled to open on October 13 for Gillnet fishing and October 15 for Purse seine fishing. After meeting with fisherman and commercial fishing representatives, WDFW made the decision to not open planned fisheries on the scheduled dates to focus fishing opportunities on the historical peak of the fall chum return in later weeks. There is insufficient time to adopt permanent rules.
