WAC 220-312-06000E Freshwater exceptions to statewide rules—Columbia River.

Effective January 1 through April 15, 2021, the provisions of WAC 220-312-060 regarding recreational steelhead seasons from the I-182 Bridge at Richland to the Old Hanford townsite powerline crossing, shall be as described below. All other provisions of WAC 220-312-060 not addressed herein remain in effect unless otherwise amended by emergency rule:

(1) From I-182 Bridge to WDFW markers ¹/₄ mile downstream of the Ringold Wasteway outlet: Steelhead:

Effective January 1 through March 31, 2021: Closed.

(2) From WDFW markers ¹/₄ mile downstream of the Ringold Wasteway outlet to ¹/₂ mile upstream of Ringold Springs Hatchery Creek: Steelhead:

Effective January 1 through April 15, 2021: Closed.

(3) From ¹/₂ mile upstream of Ringold Springs Hatchery Creek to the Old Hanford townsite powerline crossing: Steelhead:

Effective January 1 through March 31, 2021: Closed.
