Reasons for this finding: The Marine Area 11 winter Chinook fishery is scheduled to open November 1, with a total encounters limit of 1,093, an unmarked encounters limit of 256, and a sublegal encounters limit of 732 Chinook. A reduction in open days was agreed to by WDFW, the Puget Sound Recreational Fishery Advisors, and representatives of the Marine Area 11 community to extend the season as long as possible. The winter Chinook season is scheduled to close December 31.

NEW SECTION

WAC 220-313-06000J Puget Sound salmon—saltwater seasons and daily limits.

Effective November 1 through December 31, 2022, for Catch Record Card Area 11, except year-round piers listed in WAC 220-313-060 (9)(g), the following provisions of WAC 220-313-060 regarding salmon seasons shall be modified as described below. All other provisions of WAC 220-313-060 not addressed herein, or unless otherwise amended by emergency rule, remain in effect:

- (a) Open Sunday through Wednesday each week:
 - (i) Daily limit 2, including no more than 1 Chinook.
 - (ii) Release coho, chum, and wild Chinook.
- (b) Closed Thursday through Saturday each week.
