EMERGENCY RULE

Reasons for this finding: This rule is necessary to add commercial gillnet fishery openings targeting chum salmon in Puget Sound Salmon Management and Catch Reporting Areas 10 and 11. The latest in-season runsize estimate for South Sound chum salmon based on test fishing is large enough to an additional opening. There is insufficient time to adopt permanent rules.
