Reasons for this finding: The 2023 recreational clam, mussel, and oyster seasons are set in permanent rule-making that is currently ongoing. Some beaches must be closed via emergency regulation because permanent rules won't become effective in time to update seasons currently described in permanent WAC. Therefore, WDFW is closing Penrose State Park to the harvest of clams, mussels, and oysters immediately. This change will be reflected in permanent rulemaking for 2023. Immediate adoption of this rule is necessary for the preservation of the public health, safety, or general welfare. Observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to public interest. There is insufficient time to adopt permanent rules.
