EMERGENCY RULE

Reasons for this finding: This emergency rule is necessary to provide additional angling and harvest opportunity for trout in West Medical Lake prior to the scheduled treatment with the piscicide rotenone. There is insufficient time to adopt permanent rules.

NEW SECTION

WAC 220-312-05000Y Freshwater exceptions to statewide rules—Eastside.

Effective immediately, through October 13, 2024, the following provisions of WAC 220-312-050, regarding gamefish seasons, and trout daily limits for West Medical Lake shall be modified as follows. All other provisions of WAC 220-312-050 remain in effect unless modified by emergency rule:

Medical Lake, West (Spokane County):

- (a) Trout: No daily limit.
- (b) Other game fish: Closed.
