Reasons for this finding: This rule is needed to close recreational hatchery steelhead and coho harvest in Methow River				
and the mainstem upper Columbia River. The allowable incidental take (i.e., mortality) of wild steelhead will be at or near				
maximum limits by January 20. In addition, hook-and-line hatchery broodstock collection efforts for wild steelhead will begin				
in February. This break in pressure increases the likelihood of meeting broodstock collection goal in the timeframe needed. There is insufficient time to adopt permanent rules.
