NEW SECTION

WAC 220-312-06000F Freshwater exceptions to statewide rules—Columbia River.

Effective February 22 through April 30, 2025, the provisions of WAC 220-312-060, WAC 220-312-030, and WAC 220-316-010 regarding white sturgeon retention seasons from Bonneville Dam to John Day Dam are as follows. All other provisions of WAC 220-312-060, WAC 220-316-010, and WAC 220-312-030 not addressed in this section remain in effect unless otherwise amended by emergency rule:

(1) From Bonneville Dam upstream to The Dalles Dam, including adjacent tributaries:

White sturgeon: Closed to retention. Catch and release fishing only.

(2) From The Dalles Dam upstream to John Day Dam, including adjacent tributaries:

- (a) February 22 and February 27, 2025: It is permissible to retain white sturgeon: Daily limit 1. Minimum fork length 43 inches. Maximum fork length 54 inches.
- (b) February 23 through February 26 and February 28 through April 30, 2025: White sturgeon: Closed to retention. Catch and release fishing only.
