WAC 220-312-05000B Freshwater exceptions to statewide rules—Eastside.

Effective immediately, until further notice, the following provisions of WAC 220-312-050, regarding recreational fishing seasons for Cle Elum River shall be modified as follows. All other provisions of WAC 220-312-050 remain in effect unless modified by emergency rule:

Cle Elum River from the green bridge approximately 2,000 feet downstream of Cle Elum Dam, upstream to the Dam: Closed waters.
