Reasons for this finding: Survey results show that adequate clams are available in Razor Clam Areas 1, 3, 4 and 5 for recreational harvest. Washington Department of Health has certified clams from these Razor Clam Areas 1, 3, 4, and 5 to be safe for human consumption. There is insufficient time to adopt permanent rules.

NEW SECTION

WAC 220-330-16000G Razor clams – Areas and Seasons.

Notwithstanding the provisions of WAC 220-330-160, it is unlawful to take, dig for or possess razor clams taken for personal use from any beaches in any razor clam area except as provided for in this section:

- (1) Effective April 12 through April 18, 2025, razor clam digging is permissible in Razor Clam Areas defined in WAC 220-330-160 on dates and times listed below:

Razor Clam Area	Date	Time
Area 1	April 12 through April 18	From 12:01 a.m. to 11:59 a.m.
Area 2	Closed	Closed
Area 3	April 12 through April 18	From 12:01 a.m. to 11:59 a.m.
Area 4	April 13, 14, 17, and 18	From 12:01 a.m. to 11:59 a.m.
Area 5	April 12, 15, and 16	From 12:01 a.m. to 11:59 a.m.
Area 6	Closed	Closed

- (2) It is unlawful to dig for razor clams at any time in the Long Beach and Copalis Beach Clam sanctuaries defined in WAC 220-320-130.

REPEALER
