Under RCW 34.05.350 the agency for good cause finds:

Reasons for this finding: This regulation is needed to ensure an orderly fishery, manage the fishery within court-ordered sharing requirements, and meet conservation objectives. Harvestable amounts of spot shrimp are available, but recreational shares will only support a limited number of open days in the Marine Areas listed in this section. In addition, this emergency regulation opens the seasons in Marine Areas 4 east of the Bonilla-Tatoosh line, 5, 6 and 7 one hour before sunrise to one hour after sunset, which is the default daily start time and end time for those areas. **The eastern portion of Marine Area 9,** Marine Area 10 outside Elliott Bay, Marine Area 11, and Marine Area 13 will remain closed to spot shrimp harvest for conservation reasons. There is insufficient time to adopt permanent rules.

NEW SECTION

WAC 220-330-07000C Shrimp—Areas and Seasons.

Notwithstanding the provisions of WAC 220-330-070, effective May 21, 2025, until further notice, it is unlawful to fish for or possess shrimp taken for personal use in all waters of Marine Areas 4 (east of the Bonilla-Tatoosh line), 5, 6, 7, 8-1, 8-2, 9, 10, 11, 12, 13 and the Discovery Bay Shrimp District, except as provided for in this section:

- (1) Marine Areas 4 (east of the Bonilla-Tatoosh line) and 5: Open daily for all shrimp species beginning May 21, from 1 hour before official sunrise to 1 hour after official sunset, until further notice.
- (2) Marine Area 6 (excluding the Discovery Bay Shrimp District): Open for all shrimp species from 1 hour before official sunrise to 1 hour after official sunset on May 21 through 23, June 6 through 7, June 20 through 21, and July 18 through 19.
- (3) Discovery Bay Shrimp District: Open for all shrimp species May 21 from 9:00 a.m. through 3:00 p.m..
- (4) Marine Area 7 South: Open for all shrimp species from 1 hour before official sunrise to 1 hour after official sunset on May 21 through May 23 and June 6 through June 7. Only that portion of Marine Area 7 South that is west of a line projected due south from Point Colville on Lopez Island and east of a line projected due south from Cattle Point on San Juan Island, is open from June 20 through 21 for all shrimp species.
- (5) Marine Area 7 East: Open for all shrimp species from 1 hour before official sunrise to 1 hour after official sunset on May 21 through 23 and June 6 through 7 for all shrimp species.
- (6) Marine Area 7 West: Open for all shrimp species from 1 hour before official sunrise to 1 hour after official sunset on May 21 through 23, June 6 through 7, June 20 through 21, and July 18 through 19.
- (7) Marine Areas 8-1 and 8-2:
 - (a) Open for all shrimp species May 21 and June 6 from 9:00 a.m. through 1:00 p.m.
 - (b) Divers may take shrimp by hand or hand-held device from 7:00 p.m. until midnight on May 21 and June 6 in Marine Area 8-2.
- (8) Marine Area 9: Open for all shrimp species in the waters west of a line projected from Possession Point (47.905036 -122.380062) to Apple Cove Point (47.817348 -122.484381) on May 21 from 9:00 a.m. through 1:00 p.m. The portion of Marine Area 9 east of a line projected from Possession Point to Apple Cove Point is closed.
- (9) Marine Area 10 (inside Elliott Bay): That portion of Marine Area 10 east of a line projected from West Point to Alki Point is open for all shrimp species May 21 from 9:00 a.m. through 1:00 p.m.
- (10) Marine Area 10 (outside Elliott Bay): That portion of Marine Area 10 west of a line projected from West Point to Alki Point will remain closed.

- (11) Marine Area 12: Open for all shrimp species May 21, May 22, June 4, June 18, and July 2 from 9:00 a.m. through 1:00 p.m..
