**Purpose:** This emergency rule:

**WAC 220-340-52000E**

- (1) Maintains areas open to commercial spot shrimp harvest effective in Puget Sound.
- (2) Designates the commercial spot shrimp catch accounting periods and catch limits.
- (3) Implements a reduced pot limit in Region 5 concurrent with RCW 77.50.100.
- (4) Opens sub-regions 1B and 1C to commercial non-spot shrimp pot harvest effective immediately.
- (5) Maintains areas open to commercial non-spot shrimp harvest effective in Puget Sound.
- (6) Designates the commercial non-spot shrimp catch accounting periods and bi-weekly catch limit for harvest from Region 1 and 2E.

**WAC 220-340-53000H**

- (1) Opens sub-regions 1B and 1C to commercial shrimp trawl effective immediately.
- (2) Maintains areas open to commercial shrimp trawl harvest in Puget Sound.
- (3) Designates hard opening for Puget Sound beam trawl areas.
- (4) Designates early opening dates for select areas contingent on observer coverage.

**EMERGENCY RULE**

Under RCW 34.05.350 the agency for good cause finds:

- ☒ That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.

**Reasons for this finding:** Permanent rules regulating state commercial shrimp harvest in Puget Sound and the Strait of Juan de Fuca require the adoption of harvest seasons contained in this emergency rule. This emergency rule is necessary to prosecute state commercial shrimp pot and trawl fisheries in Puget Sound. These rules delay non-spot harvest in sub-regions 1B and 1C to allow for more time to evaluate the ovigery status of shrimp and structure fisheries that minimize interaction with egg-bearing females. This rule allows harvesters to respond to dynamic changes in market conditions and promotes full utilization of both the commercial spot and non-spot shares. These rules are in congruence with co-manager agreements. There is insufficient time to adopt permanent rules.

NEW SECTION

**WAC 220-340-52000E Commercial shrimp pot fishery – Puget Sound.**

Notwithstanding the provisions of WAC 220-340-520, effective immediately, until further notice, it is unlawful to fish for shrimp for commercial purposes using pot gear in Puget Sound except as provided for in this section:

(1) Spot Shrimp Pot Harvest:

- (a) Spot shrimp harvest is permitted as indicated in the following table opening one hour before official sunrise on the first day of the open period. Any closures take effect one hour after official sunset on the closing day.

- (b) The first spot shrimp catch accounting period started one hour before official sunrise on May 1, 2025, and proceeds until one hour after official sunset on July 29, 2025.

It is unlawful for the combined total harvest during the first spot shrimp accounting period to have exceeded 5,000 pounds of spot shrimp per license from all Geographical Management Units combined, except for MFSF Catch Area 29.

Catch from MFSF Catch Area 29 does not contribute towards a license's catch accounting period harvest limit.

- (c) The second spot shrimp catch accounting period will start one hour before official sunrise on July 30, and proceed until one hour after official sunset on August 19, 2025.

- (d) Harvesters may deploy no more than 50 spot shrimp pots per license in Shrimp Management Region 5.
- (e) Spot shrimp harvested from different geographical management units (as noted in subsection (1)(a)) on the same day must be kept physically separate and labeled with the MFSF Catch Area of harvest.
- (f) It is lawful to possess deactivated non-spot shrimp pots on-board a commercial vessel that is listed on a Puget Sound shrimp pot license while fishing for spot shrimp.

A deactivated pot is un-baited, has the drawstring or door fastened open, and/or is unable to be readily fished.

(2) Non-spot shrimp pot harvests:

- (a) Non-spot shrimp pot harvest is permitted as indicated in the following table opening one hour before official sunrise on the first day of the open period. Any closures take effect one hour after official sunset on the closing day.

- (c) It is unlawful for total harvest of non-spot shrimp to exceed 1,400 pounds per non-spot shrimp catch accounting period from subregions 1B, 1C, and Region 2E combined during catch accounting periods 1 through 12.
- (d) There is no weekly harvest limit of non-spot shrimp from sub-region 1A, Region 2W, Region 3, or the Discovery Bay Shrimp District.
- (e) Non-spot shrimp harvested from different geographical management units (as noted in subsection (2)(a)) on the same day must be kept physically separate and labeled with the MFSF Catch Area they were harvested from.
- (f) It is lawful to possess deactivated spot shrimp pots on-board of a commercial vessel that is listed on a Puget Sound shrimp pot license while fishing for non-spot shrimp.

A deactivated pot is un-baited, has the drawstring or door fastened open, and/or is unable to be readily fished.

## NEW SECTION

### **WAC 220-340-53000H Commercial shrimp trawl fishery – Puget Sound.**

Notwithstanding the provisions of WAC 220-340-530, effective immediately, until further notice, it is unlawful to fish for shrimp for commercial purposes using beam trawl gear in Puget Sound except as provided for in this section:

- (a) Non-spot shrimp beam trawl harvest is permitted starting one hour before official sunrise on the season opening dates listed for each of the areas detailed in this subsection. Any closures take effect one hour after official sunset on the closing day.

Subarea 23A East, MFSF Catch Areas 23B, and MFSF Catch Area 25A outside of the Discovery Bay Shrimp District.	Immediately, 2025, until further notice.

MFSF Catch Area 29	Immediately, 2025, until further notice.

- (b) Non-spot shrimp beam trawl harvest is permitted starting one hour before official sunrise in the areas detailed in this subsection. To participate in the fisheries listed in this subsection harvesters are required to take a WDFW on-board observer on their first trip to these areas. If by-catch sampling criteria are not met these areas will open on the later dates described in WAC 220-340-530 (7)(d) and (7)(e).
