NEW SECTION

WAC 220-312-04000Q Freshwater exceptions to statewide rules—Puget Sound.

Effective immediately, through July 13, 2025, provisions of WAC 220-312-040 regarding salmon and game fish seasons for Skykomish river shall be as described in this section. All other provisions of WAC 220-312-040 not addressed in this section, or unless otherwise amended by emergency rule remain in effect:

Skykomish River (Snohomish County):

- (a) From the mouth to Wallace River:
 - (i) Salmon; effective immediately through July 10: Daily limit 4 including no more than 2 adults. Release all salmon other than hatchery Chinook.
 - (ii) Game fish; effective immediately, through July 10:
 - (A) Dolly varden/Bull trout: Minimum size 20 inches. May be retained as part of trout daily limit;
 - (B) Trout: Statewide minimum size/daily limit, except cutthroat trout and wild rainbow trout minimum size 14 inches;
 - (C) Other game fish: Statewide minimum size/daily limit;
 - (iii) All species; effective immediately, through July 10:
 - (A) Only single-point hooks allowed;
 - (B) Night closure.
- (b) From the Railroad Bridge at Big Eddy to the confluence of North and South forks:

Game fish; effective immediately, through July 13:

- (i) Dolly varden/Bull trout: Minimum size 20 inches. May be retained as part of trout daily limit;
- (ii) Trout: Statewide minimum size/daily limit, except cutthroat trout and wild rainbow trout minimum size 14 inches;
- (iii) Other game fish: Statewide minimum size/daily limit;
- (iv) Anti-snagging rules in effect;
- (v) Selective gear rules in effect;
- (vi) Night closure.
