Reasons for this finding: This regulation is needed to ensure an orderly fishery, manage the fishery within court-ordered sharing requirements, and meet conservation objectives. There is sufficient allocation of spot shrimp to open the "all shrimp" fisheries in the marine areas indicated. It maintains all the non-spot shrimp fisheries that are currently open. There is insufficient time to adopt permanent rules.

#### WAC 220-330-07000F Shrimp—Areas and Seasons.

Notwithstanding the provisions of WAC 220-330-070, effective June 20, 2025, until further notice, it is unlawful to fish for or possess shrimp taken for personal use in all waters of Marine Areas 4 (east of the Bonilla-Tatoosh line), 5, 6, 7, 8-1, 8-2, 9, 10, 11, 12, 13 and the Discovery Bay Shrimp District, except as provided for in this section:

- (1) Marine Areas 4 (east of the Bonilla-Tatoosh line) and 5: Open daily for all shrimp species from 1 hour before official sunrise to 1 hour after official sunset, until further notice.
- (2) Marine Area 6 (excluding the Discovery Bay Shrimp District): Open for all shrimp species from 1 hour before official sunrise to 1 hour after official sunset on June 20 through 21 and July 18 through 19.
- (3) Discovery Bay Shrimp District: Open for all shrimp species on June 20 from 9:00 a.m. through 3:00 p.m.
- (4) Marine Area 7 West: Open for all shrimp species from 1 hour before official sunrise to 1 hour after official sunset on June 20 through 21 and July 18 through 19.
- (5) Marine Areas 8-1 and 8-2:
  - (a) Open for all shrimp species on June 20 from 9:00 a.m. through 1:00 p.m.
  - (b) Divers may take shrimp by hand or hand-held device from 7:00 p.m. until midnight on June 20 in Marine Area 8-2.
- (6) Marine Area 9: Open daily through October 15 for shrimp species other than spot shrimp. It is unlawful to set or pull shrimp gear in waters greater than 150 feet deep. All spot shrimp caught must be immediately returned to the water unharmed.
- (7) Marine Area 10 (inside Elliott Bay): That portion of Marine Area 10 east of a line projected from West Point to Alki Point is open for all shrimp species June 20 from 9:00 a.m. through 1:00 p.m.
- (8) Marine Area 11: Open daily through October 15 for shrimp species other than spot shrimp. It is unlawful to set or pull shrimp gear in waters greater than 150 feet deep. All spot shrimp caught must be immediately returned to the water unharmed.
- (9) Marine Area 12: Open for all shrimp species 1:00 June 18 and July 2 from 9:00 a.m. through p.m.

(10) Marine Area 13: Open daily through October 15 for shrimp species other than spot shrimp. It is unlawful to set or pull shrimp gear in waters greater than 200 feet deep. All spot shrimp caught must be immediately returned to the water unharmed.
