Attached is a proposal to amend a rule that would allow using electronic calling devices and decoys for the late Washington State snow goose hunting season. As I touched a bit on the form, snow geese are very difficult to hunt and decoy. They don't pattern well, always on the move and most of the time will not come into standard decoys.

It is nice to have the opportunity to hunt snow geese in a late season and I am assuming this is being allowed because of the fast growing numbers of snow geese and the damage they can cause to crops.

Example is the limits in Eastern Washington Zone 4, the limits during the late season are raised from 10 to 20 per day. I think the percentages of limits taken on Snow geese are extremely low and seldom met.

This proposal will help in trying to control snow goose numbers, protect crops and in the long run snow geese nesting grounds, their food source supplies that are getting over run in snow geese numbers. Many States across the United States see the problem Snow geese are causing and have implemented programs and rule changes while hunting snow geese. Such as big limits, no limits, no plugs in shot guns required and electronic devices allowed. I'm heading to Arkansas the middle of this month for a snow goose hunt. Because I have a Washington migratory license and stamp I don't need to purchase an Arkansas hunting license, just a get free Arkansas snow conservation endorsement.

Hi Kyle,

Thanks for the clarification. I missed that part of the current rule package. One slight difference between the petition language and the proposed amendment in the CR102 is that it includes decoys. I'm not sure if this is significant – but I agree that the best approach is to talk to the petitioner and see if they would be willing to withdraw the petition and participate in the rule making process instead. Afterwards, a new petition could be filed if the petitioner thought it was necessary.
