## #2. Amend Rule -

I am requesting the following change: I would like to change the season closure date of Park Lake, Blue Lake, and Deep Lake in Grant County from September 30<sup>th</sup> to October 31<sup>st</sup>.

**This change is needed because:** The lake currently closes on September 30<sup>th</sup> and this limits the opportunity for fishing in the fall when weather and water conditions are cooler, aquatic life and fish are more active due to the conditions. By keeping the lake open until October 31<sup>st</sup> this would provide more fishing opportunities. Many sports fishers continue to fish statewide until inclement weather restricts travel and catching opportunities. The following fishermen are in support of this Amended Rule petition:

The effect of this rule change will be: Fishermen/women from around the state would be allowed to continue to fish during prime conditions. This rule change would extend the season for the mentioned lakes until Oct. 31<sup>st</sup>. The rules change would provide a positive economic impact to the lodging, private campgrounds and Sun Lakes State Park, because fishers from across the state would continue to come to the area for great fishing during the beautiful fall season.
