#### NOF #1: WDFW Mission

- State's Commercial Objectives for 2025:
  - Understand precautions due to low abundance.
  - Craft fisheries when/where conservation measures can be attained.

- WDFW commitment:
  - Using all data and tools at our disposal investigate the most prudent path to 2025 fisheries.
  - Thinking outside the box; taking different ideas into consideration.
  - Soliciting input from the fishers.



#### WAC 220-354-140

- Since 1972, state law regarding the setting and operation of gillnets targeting salmon has remained largely the same, with the original 1972 language reading "The nets shall be operated substantially in a straight line. Circle setting with a gill net or setting a gill net other than substantially in a straight line shall be unlawful."
- To meet the federal requirement of having a light at the end of the net "most distant from the vessel" at night, the nets need to be fished in a substantially straight line at night.

#### **Proposed Changes:**

#### WAC 220-354-140

#### Puget Sound salmon—Lawful gear—Gillnet.

- It is unlawful to use drift gillnet salmon gear in Puget Sound that exceeds 1,800 feet in length or contains meshes of a size less than 5 inches.
- (2) It is unlawful to use skiff gillnet salmon nets in Puget Sound that exceed 600 feet in length, 90 meshes in depth, or that contain meshes of a size less than 5 inches, except in Area 9A, where skiff gillnets are further restricted by not being more than 60 meshes deep. It is unlawful to retrieve skiff gillnets by any means except by hand (no hydraulics may be used). It is unlawful to fail to attend to skiff gillnets at all times.
- (3) Vessels engaged in gillnet fishing at any time between sunset and sunrise shall, display at the end of the net most distant from the vessel on all-round (32-point) white light visible for a minimum of two nautical miles and displayed from at least three feet above the surface of the water. During hours of darkness Odrift gillnets and skiff gillnets shall be set and operated substantially in a straight line.
- (a) It is unlawful to set <u>drift gillnets and skiff gillnets</u> such nets in a circle or to set them in other than a substantially straight line, except during daylight hours if there is A-1 buoys attached 12 feet prior to either end of the net, fishers may be set and operate the last 12 feet of the net in a semi-circle, also known as a "J" hook as long as the end of the net does not hook back past the A-1 buoy attached at the 12 foot mark. Daylight hours for this subsection is defined as, sunrise to sunset during open gillnet seasons. Considering currents, and weather drift gillnets and skiff gillnets shall be set and operated in a substantially straight line.
- (ab) It is unlawful to operate any drift gillnet, attended or unattended, unless there is affixed, within five feet of each end of the net, two red size A-3 buoys, marking the visible end of the cork line portion of the net. One of the two buoys shall be marked in a visible, legible, and permanent manner with the name and gillnet license number of the fisher. It is unlawful to fail to attend to drift gillnets at all times.
- (bc) The cork line portion of the net shall be marked every 300 feet 50 fathoms of the net with size A-1 buoys.



#### WAC 220-354-050

#### **Proposed Changes**

- Title change to "Registration and Limited Participation Salmon Net Fisheries"
- Expansion to 7/7A, 7B, and 12/12B for registration purposes, but limits only to be applied when necessary
- Pre-season online application submission deadlines that correspond to each fishery
- In-season weekly online registration entry requirements via e-mail, phone, and text link



### Why LP or Registration Fisheries

#### Purpose of LP/Registration Fisheries

- Specific management objectives for a species or area (i.e., limited harvestable surplus based on escapement and/or hatchery goals)
- Full-fleet participation may exceed co-manager or international agreed-to harvestable share and/or treaty defined harvest limit
- Bycatch Management: Helps track and reduce nontarget catch (i.e., modeled sockeye or chinook impacts in pink fishery)



### Why LP or Registration Fisheries Cont.

#### Benefits of LP:

- Achieve allocation within narrow management margins
- In-season catch projections and assessment with higher confidence
- Improving co-manager trust and confidence around operating fisheries within pre-season agreed-to impact rates
- Improving in-season observer catch tracking to compare and validate quick reports
- Scheduling flexibility (In-season preference selection)

Implications for Areas where the state traditionally prosecutes full fleet fisheries

• Example: Hood canal Purse Seine – 35 vessels completed pre-season LP Application, all 35 check (yes) on in-season form, all 35 go fishing and can still access other areas on the same day pending they land the fish before accessing different area or hold separately

#### Limited Participation Application Process

Submit Pre-Season LP Application online for each fishery

Pre-season Deadline: One Month Before Fishery

WDFW sends In-Season Y/N Form every Friday Inseason

Submit the **In-Season Y/N Form by Monday at noon** 

#### **Go Fishing!**

- Everyone who said yes, can fish!
- If fishery is limited, selection is based on who said yes





- What fisheries you plan to fish next week that correspond to your pre-season application
- Preferred fishing days



# Pre-season Application & Weekly In-season Form Distribution

- Post-NOF Letter Sent with a link and website location
- **Pre-season Application** Available on the website
- Location of Pre-season Application— Same place you find the hotline
- Pre-season Application Deadline: Month before fishery opens
- Priority List Posted for each Area/Fishery: A minimum of one week prior to fishery opens
- In-season Y/N Form Emailed every Friday and a link posted on hotline
- In-season Y/N Form Deadline: Monday by noon
- In-season E-regulation with list of registered fishers posted on hotline
- Pre-season and In-season applications: online-only process



### NOF #1: NT Season Planning

#### 2025 Preliminary Expectations by Area:

- **6D:** Start week 39. No expected issues. Maintain closure areas
- **7/7A Pink/Sockeye:** Pink opportunity likely and sockeye retention to be discussed in-season (domestic sockeye payback)
- 7/7A Chum: Chum opportunity not strong, to be evaluated in-season (international and domestic chum payback)
- **7B/7C:** Coho and Chum forecasts potentially allow for full schedule and proposed adjustments on earlier timing and daylight hours to be evaluated in side-model runs before determining if appropriate to propose to comanagers
- 8/8A/8D: Proposed fisheries in 'public comments portal' being evaluated in sidemodel runs before determining if appropriate to propose to comanagers



### NOF #1: NT Season Planning

#### 2025 Preliminary Expectations by Area:

- **9 Chum:** Not being considered by the state at this time due to lack of Puget Sound wide comprehensive chum management plan and comanager sharing agreements
- **9A:** Proposed fisheries as full schedule. Closure areas to be discussed. Chum release requirement
- 10 & 11 Chum: Full fleet fisheries to be proposed for week 42 based on pre-season forecast
- **10 Pink:** 300 chinook encounter limit being reviewed, split between GN and PS, with effort and schedule similar to 2023
- 12A: HC Coho close to critical threshold
- 12 & 12B Chum: Full fleet fisheries to be proposed for week 42 based on pre-season forecast
- 12C: Beach Seine single day schedule with additional day to be discussed in-season based on hatchery and comanager discussion
