WAC 220-354-050 (Proposed Revisions)

WAC 220-354-050 -Registration and Limited participation salmon net fisheries. (1) When the director determines that a harvestable amount of salmon appears to be available, but that unknown fishing effort and/or full-fleet fishing effort has an unacceptable risk of exceeding the available harvest or compromises other specific management objectives, the director may authorize a registration and/or limited participation fishery in extreme terminal fishing areas in order to provide additional opportunities for net fisheries where they might not otherwise exist. Such a fishery may be authorized for experimental or developmental fisheries, fisheries necessary to refine run size data, fisheries necessary to provide biological information, or in cases where:

- (a) Other specific management objectives have been stated for the species and area in question; or
- (b) There is a reasonable expectation that foregone opportunity will be <u>claimed</u> and the harvestable surplus cannot be carried forward to the next year of harvest; and

- (c) Full-fleet participation with time, space, or gear restrictions cannot achievemay exceed the harvest goal.
- (2) Only licensed commercial salmon fishers may participate in a registration and/or limited participation fishery.— Each license number may only be entered once per fishery. If multiple individuals share the same license number, only one entry may be submitted. Only the license owner, primary operator, or alternate operator(s) tied to the designated license number used for the registration fishery application may participate. Only one application entry per license listing is allowed. per license. Fishers
- (3) The Commercial Salmon license holder, primary operator or alternate operator(s) must complete the online registration form and indicate the specific fishery they are interested in registering for by selecting the appropriate box on the form.

 Applicants must complete and submit the form with the following quidelines and deadlines to participate in the Puget Sound net fisheries below: who wish to

(c) Applicants must provide a valid Vessel ID per license number.

(d) Interested fApplicants ishers must provide a valid email address and valid -message message-capable phone number -to
at which they may be contacted -on a weekly basis to fill out an
in-season registration form.

(e) Applicants must submit a separate registration

application online for each marine area specific fishery they

wish to register for. It is recommended that the primary or

alternate(s) operator apply for the registered fishery, not the owner.

- (3) Each year the department will, from the list of interested fishers, use random selection from the list of approved online registration applications to create an ordered priority list for gillnet fishers and a ordered priority list for purse seine fishers by area listed in section 2(b). Priority registers registration lists by area and fishery will be available for inspection at the department's Olympia office, or upon written request to the department. Once the priority lists have been created, sale or transfer of the license shall invalidate the receiver from participation in that year's registration and/or limited participation fishery.
- (4) The number of units of each gear type selected to participate in a registered limited participation fishery will reflect the most recent ratio of gear types in the full-fleet fishery directed at the species in question, except when conservation concerns, biological data collection needs, or specific management objectives dictate alternative ratios or use of a single gear type.



WAC 220-354-050 (Proposed Revisions Cont.)

(5) When a registration and/or limited participation fishery is authorized, the department will contact fishers from the priority register every Friday via e-mail and text message starting the management week before the first pre-season scheduled opening date of the applicant's selected fishery. at least twenty-four hours prior to the opening of the fishery. When a fisher cannot be contacted after reasonable effortby Monday at noon the following management week, and/or has declined to decided to not respond to an online department approved In-season registration form, the department will select the next name, until the maximum number of allowable units of gear is reached. If not reached, the fisher's name will remain at the priority position, but the fisher may not participate in that registration or limited participation fishery. Agreement to participate, or declining to participate, will remove the fisher from the priority position, and place the name at the bottom of the priority list.

(b) Agreement to participate in an authorized <u>registration</u> or limited participation fisheries will may require a department observer on board a participating vessel. An additional permit may be required by a participating vessel to allow for a department observer to complete work associated with biological data collection needs meeting specific management objectives.

(c) Priority registered applicants will receive a request for a completed In-season registration form every Friday starting one-week prior to the fishery and for the duration of the fishery, and must submit the In-season registration form online by Monday at noon. Late submissions will not be accepted for that week's fishery. You must complete a separate In-season entry form for each fishery you registered to participate in that week. A new form is required to be submitted to be considered for next week's fishery. You will be notified of your eligibility to participate via the hotline, website and or/email.

- (6) Examples of specific management objectives include but are not limited to:
- (a) Reducing levels of incidental catch of wild salmon stocks;
- (b) Reducing incidental catch of nontarget salmon species originating from regions other than the fishing area; or



WAC 220-354-140 (Proposed Revisions)

Puget Sound salmon—Lawful gear—Gillnet.

- (1) It is unlawful to use drift gillnet salmon gear in Puget Sound that exceeds 1,800 feet in length or contains meshes of a size less than 5 inches.
- (2) It is unlawful to use skiff gillnet salmon nets in Puget Sound that exceed 600 feet in length, 90 meshes in depth, or that contain meshes of a size less than 5 inches, except in Area 9A, where skiff gillnets are further restricted by not being more than 60 meshes deep. It is unlawful to retrieve skiff gillnets by any means except by hand (no hydraulics may be used). It is unlawful to fail to attend to skiff gillnets at all times.
- (3) <u>Vessels engaged in gillnet fishing at any time between sunset and sunrise shall, display at the end of the net most distant from the vessel on all-round (32-point) white light visible for a minimum of two nautical miles and displayed from at least three feet above the surface of the water. During hours of darkness <u>Od</u>rift gillnets and skiff gillnets shall be <u>set and</u> operated substantially in a straight line.</u>
- (a) It is unlawful to set <u>drift gillnets and skiff gillnets such nets</u> in a circle or to set them in other than a substantially straight line, except during daylight hours if there is A-1 buoys attached 12 feet prior to either end of the net, fishers may be set and operate the last 12 feet of the net in a semi-circle, also known as a "J" hook as long as the end of the net does not hook back past the A-1 buoy attached at the 12 foot mark. Daylight hours for this subsection is defined as, sunrise to sunset during open gillnet seasons. Considering currents, and weather drift gillnets and skiff gillnets shall be set and operated in a substantially straight line.
- (ab) It is unlawful to operate any drift gillnet, attended or unattended, unless there is affixed, within five feet of each end of the net, two red size A-3 buoys, marking the visible end of the cork line portion of the net. One of the two buoys shall be marked in a visible, legible, and permanent manner with the name and gillnet license number of the fisher. It is unlawful to fail to attend to drift gillnets at all times.
- (bc) The cork line portion of the net shall be marked every 300 feet 50 fathoms of the net with size A-1 buoys.
- (4) It is unlawful to take or fish for salmon with gillnet gear in Areas 7 or 7A sockeye or pink salmon fisheries unless said gillnet gear is constructed so that the first 20 meshes below the cork line are composed of five-inch mesh, white opaque, minimum 210/30d (#12) diameter, nylon twine.
- (5) It is unlawful to take or fish for salmon with gillnet gear when recovery box(es) are required in areas defined under WAC <u>220-301-030</u> unless the gillnet vessel has aboard and uses said operable recovery box(es) as described in this subsection.
- (a) Dimensions and capacities of required recovery boxes:
- (i) Recovery boxes must have two chambers, if one box, or one chamber in each box, if two boxes.
- (ii) Each recovery box chamber must have an inside length measurement of 48 inches, an inside width measurement of 10 inches, and an inside height measurement of 16 inches.

Relevant Background

Puget Sound is a heavily utilized body of water with a variety of user groups ranging from commercial cargo vessels, critical vehicle/passenger transportation services, recreational boaters, commercial fishermen, etc. This amount of vessel traffic is not present in other parts of Washington, nor Alaska. Washington State and Federal regulations acknowledge these challenges in part by placing addition regulations on gillnet fishing methods and gear. Since 1972, state law regarding the setting and operation of gillnets targeting salmon has remained largely the same, with the original 1972 language reading "The nets shall be operated substantially in a straight line. Circle setting with a gill net or setting a gill net other than substantially in a straight line shall be unlawful." Since then additional language was added to state law to increase the visibility of Puget Sound salmon drift gillnets requiring two red sized A-3 buoys within 5 ft of each end of the net, marking the visible end of the cork line portion of the net, and the cork line portion of the net must be marked every 50 fathoms with size A-1 buoys. This regulation is in place in large part to draw attention to the net's location for other transiting vessels. Further, Federal law states referencing Puget Sound, "Vessels engaged in gill net fishing at any time between sunset and sunrise in any of the waters" defining the regulated navigation are of this section shall, in addition to the navigation lights and shapes required by Part 81 of this title (72 COLREGS), display at the end of the net most distant from the vessel on all-round (32-point) white light visible for a minimum of two nautical miles and displayed from at least three feet above the surface of the water." In order to meet the federal requirement of having a light at the end of the net "most distant from the vessel" at night, the nets need to be fished in a substantially straight line at night.
