Dear Coastal Dungeness Crab Fisher:

The purpose of this letter is to provide additional information regarding the opening of the 2010-2011 coastal Dungeness crab fishery. In our letter dated November 24, 2010 we promised to provide additional details regarding the opening of the state fishery north of Klipsan Beach, Washington following our final discussions with the Quinault Indian Nation (QIN).

The discussions with QIN have now been finalized. They include a state opening between Klipsan Beach, Washington and Destruction Island, Washington on January 15, 2010. This allows for a 47 day head start for QIN fishers. The head-start is two days shorter than the head start period agreed to last season. To avoid further delaying the state season opening beyond January 15th, WDFW agreed to shorten the pre-soak period by 24 hours and to keep the Primary QIN SMA in place for seven additional days compared to the amount of time it was in place last season.

Preliminary information on the opening in the area between Destruction Island and the U.S Canadian border is provided below. Confirmation of the opening date in this area will be provided in a follow up letter.

Please be sure to familiarize yourself with the management measures described below before you begin your fishing operations and stay informed relative to additional changes.

OPENING DATES AND FAIR START PROVISIONS:

Klipsan Beach to WA/OR Border including Willapa Bay:

The coastal Dungeness crab fishery opened to state fishers from Klipsan Beach (46°28.00) to the WA/OR border (46°15.00), including Willapa Bay (*note the western boundary description), on **December 1, 2010**. A 64-hour gear pre-set period started at 8:00 AM, November 28, 2010. Vessel hold inspections were conducted on November 30, 2010, starting at noon. Fishing was permitted in this area at 12:01 a.m. on December 1, 2010.

- **In recognition of the industry sponsored delay of the season opening, the haul period has been extended through 11:59 p.m. on December 14, 2010.** It is lawful to use a vessel not designated on a coastal Dungeness crab license to transport or deploy up to 250 pots at any one time through midnight December 14, 2010. The primary or

alternate operator of the license associated with the gear must be on board the vessel when the gear is deployed.

- Fishers participating in the fishery south of Klipsan Beach or in Willapa Bay are subject to reduced pot limits. Fishers with permanent pot limits of 500 and 300 will be allowed to use 400 or 250 pots, respectively. Unused buoy tags must be on board vessels until the temporary pot limit is lifted.
- Vessels that fish in the area between Point Arena, CA and Klipsan Beach and/or in Willapa Bay before the ocean area north of Klipsan Beach opens are subject to the fair start provisions described below.
- The boundary between the Willapa Bay and the ocean waters is distinguished by a straight line connecting the following coordinates:

*Cape Shoalwater: 46°44.76 N - 124°05.76 W

Leadbetter Point: 46°38.93 N - 124°04.33 W

Klipsan Beach to Destruction Island:

The state commercial fishery from Klipsan Beach to Destruction Island will open at **12:01 am, January 15, 2011**. A **40-hour** gear pre-set period will begin at 8:00 am January 13, 2010, hold inspections will be conducted starting at noon on January 14, 2011. Fishers may be required to use a temporary reduced pot limit upon the opening in this area. We will send a follow-up letter confirming whether a temporary pot limit will be required. If in effect, fishers with permanent pot limits of 500 and 300 will be allowed to use 400 or 250 pots, respectively. Unused buoy tags must be on board vessels until the temporary pot limit is lifted.

Destruction Island to U.S.-Canadian Border:

The state commercial fishery from Destruction Island to the U.S. Canadian border will **not open before 12:01 AM, January 15, 2011**. The opening in this area may be delayed past January 15 as necessary to provide 20 fishable days between December 1, 2009 and January 15, 2010. Fishers may be subject to a temporary reduced pot limit if one is implemented for the opening between Klipsan Beach and Destruction Island until such time that the reduced pot limit is lifted. If the opening in this area is not delayed and occurs simultaneously with the opening from Klipsan Beach to Destruction Island a 40-hour gear pre-set period will begin at 8:00 am January 13, 2010, hold inspections will be conducted starting at noon on January 14, 2011. Confirmation of the opening date in this area will be provided in a follow up letter.

Fair Start Provisions:

- **Klipsan Beach (46°28.00) to Oysterville (46°33.00):** Vessels that fish between Point Arena, CA and Klipsan Beach, WA, including Willapa Bay, before the area north of Klipsan Beach opens will be allowed to fish in the area between Klipsan Beach and Oysterville at **8:00 am on January 25, 2010**

- **Oysterville (46°33.00) to U.S. - Canadian Border:** Vessels that participate in the fishery between Point Arena, CA and Klipsan Beach, WA, including Willapa Bay, before the area north of Oysterville opens will be allowed to fish in the area between Oysterville and U.S. - Canadian border at **8:00 am on February 19, 2010**

SPECIAL MANAGEMENT AREAS:

Quinault:

The Quinault **primary SMA** will be closed to state fishers beginning at 12:01 AM January 15, 2011. The **primary SMA** is scheduled to remain closed to state fishers through March 20, 2011.

The Quinault **primary SMA** is described as the coastal waters shoreward of a line approximating the 27-fathom depth curve between Raft River (47°28.00) and Copalis River (47°08.00) according to the following coordinates:

- Northeast Corner: 47°28.00N. Lat. – 124° 20.70 W. Lon.
- Northwest Corner: 47°28.00N. Lat – 124°34.00 W. Lon.
- Southwest Corner: 47°08.00N. Lat. – 124°25.50 W. Lon.*
- Southeast Corner: 47°08.00N. Lat. – 124° 11.20 W. Lon.

A Quinault **secondary SMA (SSMA)** will be established to include the area shoreward of a line approximating the 27-fathom depth curve between the mouth of the Copalis River (47°08.00) and Split Rock (47°24.50) according to the following coordinates:

- Northeast Corner (Split Rock): 47°24.50 N. Lat. 124°20.00 W. Lon.
- Northwest Corner: 47°24.50 N. Lat. 124°32.40 W. Lon.
- Southwest Corner: 47°08.00 N. Lat. 124°25.50 W. Lon.*
- Southeast Corner (Copalis River): 47°08.00 N. Lat. 124°11.20 W. Lon.

***Note:** this coordinate was revised last year to better reflect the intention of following the 27 fathom depth contour.

When the area between Split Rock and Raft River opens, state fishers must pre-register with WDFW prior to deploying gear in this area. Specific details regarding SMA openings and pot limits will be made available prior to opening.

Quileute:

The Quileute SMA will be closed to state fishers beginning immediately upon the opening of the state fishery in the area from Destruction Island to U.S. Canadian border. The Quileute SMA will open to state fishers beginning at 8:00 AM, May 1, 2011.

The Quileute SMA is described as the area from Cape Johnson to Destruction Island shoreward of a line approximating 30 fathoms according to the following points:

- Northeast Corner; Cape Johnson 47°58.00 - 124°40.40
- Northwest Corner; 47°58.00 N. - 124°49.00W.
- Southwest Corner; 47°40.50 N. - 124°40.00'W.
- Southeast Corner; Destruction Island 47°40.50 - 124° 24.43

There will be a 100-pot limit in the SMA from May 1, 2011, through May 31, 2011. Fishers must pre-register with WDFW prior to deploying gear in this area.

Makah SMA:

The Makah SMA will be closed to state fishers immediately upon the opening of the state fishery in the area between Destruction Island and U.S. Canadian border and will remain closed for 30-days.

There will be a 200-pot limit in the SMA for the first 30-days following the opening of the SMA to state fishers. Fishers must pre-register with WDFW prior to deploying gear in this area.

The Makah SMA is described as the coastal waters between 48°02.15N. to 48°19.50N. east of a line connecting those points approximating the 25-fathom line according to the following coordinates:

- Northeast Corner; Tatoosh Island
- Northwest Corner; 48°19.50 N. – 124°50.45 W.
- Southwest Corner; 48°02.15 N. – 124°50.45 W.
- Southeast Corner, 48°02.15 N. – 124°41.00 W.

Other Requirements:

- a. Vessels not designated on a coastal Dungeness crab fishery license are permitted to transport or deploy up to 250 pots during the pre-soak period. The primary operator of the vessel associated with the pots being transported must be aboard the vessel while they are being deployed.
- b. All license holders will be required to carry, complete, and submit logbooks to WDFW. This information will greatly assist us in managing our fishery in the future.
- c. Notification to WDFW Enforcement is required when transiting crab through closed areas. Notification is to be made 24-hours prior to entering the area north of 47°00.00 N. Latitude by calling 360-581-3337, and reporting the vessel name, operator name, estimated amount of crab to be delivered in pounds, and the estimated date, time, and location of delivery. The following situations will require notification.

- a. Vessels transiting north of Grays Harbor with crab caught south of Klipsan beach (46°28.00) or Willapa Bay prior to the area north of Klipsan beach opening.
- b. Vessels transiting north of Grays Harbor with crab caught south of Destruction Island (47°40.50) prior to the area north of Destruction Island opening.

- d. A hold inspection certificate number is required on all fish tickets through January 31, 2011.

- e. WDFW would like your help, please call the coastal crab hotline (360-249-4628, extension 260) if you witness or have information regarding enforcement violations including fishing in closed areas, starting early, pots without buoy tags, etc.
