Sales of fish are allowed after the open period concludes, as long as the fish were landed during the open period. |
| Sanctuaries:  | Closed areas applicable to platform gear are in effect. The Spring Creek Hatchery sanctuary is not necessary this time of year.   |
| Miscellaneous:  | Quick reporting required for all Washington Fish Buyers pursuant to WAC 220-69-240.14(d), and landings must be quick reported within 24-hours of completing the fish ticket.  |

Sales of fish are allowed after the open period concludes, as long as the fish were landed during the open period. |
