## **Proposed Puget Sound Marine Recreational Seasons 2019-20**

## Primary considerations for crafting recreational seasons:

- Continued low abundances in Wild Chinook stocks specifically low forecasted returns to the Stillaguamish and Mid-Hood Canal systems.
- Continued concerns for Orca Whale recovery and the need to provide additional prey and protection.
- Strait of Juan de Fuca Wild Coho and Snohomish River Wild Coho continue to be categorized as "overfished" and will require additional consideration when crafting seasons.

## Fisheries modifications under consideration:

- Reduced time for directed Chinook in Marine Area 7.
- Directed Chinook fishery in Elliot bay
- Reduced summer quotas in areas with high wild stock impacts
- Reduced coho opportunity in the Everett Area (around the Snohomish).
- Increased coho opportunity in Areas that have been closed or had reduced opportunity in recent years.
- Moving Area 10 winter Chinook fishing later into the spring.
- Reduced Chinook size limit in South Sound and Hood Canal
- June Coho opportunity in Area 10
