**Land Management Summary**

This is an update to the 2006 Wells Wildlife Area Management Plan [http://wdfw.wa.gov/lands/wildlife\\_areas/management\\_plans/](http://wdfw.wa.gov/lands/wildlife_areas/management_plans/) that provides management direction for the 8,170 acre Wells Wildlife Area including six separate land management units: West Foster Creek (1,050 acres), Indian Dan Canyon (4,412 acres), Central Ferry Canyon (1,908 acres), Bridgeport Bar (450 acres), Washburn Island [about 250 acres – Douglas County Public Utility District (PUD) owned] and Okanogan River Units (100 acres+). The plan identifies needs and guides activities on the area based on the Washington Department of Fish and Wildlife (WDFW) Mission of “Sound Stewardship of Fish and Wildlife” and its underlying statewide



goals and objectives as they apply to local conditions. Plans are updated annually as habitat and species conditions change, as new regulations and scientific knowledge develop, as public issues and concerns evolve, and as administration of wildlife areas change. This management plan update also includes 2008 accomplishments and performance measures for 2009.

**Updates/Changes**

WDFW received a grant from the Washington Wildlife and Recreation Program to restore 70 acres of shrub-steppe habitat in old agricultural fields primarily on the West Foster Creek Unit.

Ten were released on the Bridgeport Bar Unit and 32 on the West Foster Creek Unit	Will continue trapping and releasing quail in 2009.
Survey hunting related public use through the hunter registration program to document use and wildlife population trends.	Completed. Hunting pressure and success was generally down from 2007.	Continued in 2009
Grow 75 acres of irrigated grain on Bridgeport Bar and Washburn Island (wheat, barley, corn, millet etc.) and 30 acres of dryland wheat on the Indian Dan and West Foster Creek Units.	Grew 113 acres of irrigated wheat and 20 acres of corn on Bridgeport Bar and Washburn Island. Grew 21 acres of dryland wheat on the Indian Dan and West Foster Creek Unit.	Continued in 2009

Not completed	Sites for planned releases were inspected and had established populations of bio control agents. These and additional sites will be surveyed in the spring of 2009 and insects released as needed.
Mow about 25 acres of weeds on the West Foster Creek Unit and treat 85 acres of weeds with herbicides throughout the wildlife area.	Chemically treated 20 acres of diffuse knapweed, 1 acre of leafy spurge, 2 acres of puncture vine, 47 acres of grass, 4 acres of Dalmatian toadflax, and 36 acres of Canadian thistle. Mowed about 36 acres of Canadian thistle.	Continued in 2009
Maintain one mile of firebreaks on the West Foster Creek Unit and two miles on Bridgeport Bar.	Completed	Continued in 2009

Cultivate and seed 20 to 30 acres on Bridgeport Bar to permanent cover.	Seeded 28 acres of perennial herbaceous cover on Bridgeport Bar	
Establish and irrigate about 50 acres of permanent nesting cover on Washburn Island.	Completed. Seeded 11 acres with a mix of several grasses and alfalfa. Irrigated this and the rest of the 50 acres.	Will evaluate seeding and need for additional seeding in 2009.
Work with the Bureau of Land Management and volunteers to survey bald eagle winter roosts and American white pelican and double crested cormorant using Wells Pool.	Completed. Volunteers counted pelicans and cormorants on Wells Pool. BLM, Volunteers and WDFW personnel surveyed bald eagle roosts.	Continued in 2009
Write a fire management plan including post-fire treatment of affected site(s).	Partially completed	Planned for completion in 2009
Experiment with forage kochia plantings in firebreaks.	Not completed	Planned for 2009

### **New Strategies**

The wildlife area plan identifies many strategies or activities to address the agency's strategic plan goals and objectives, why the area was purchased, habitat conditions, species presence, and public issues and concerns. No new strategies were identified.

### **2009 Performance Measures**

Performance measures for the Wells Wildlife Area are listed below. Accomplishments and progress toward desired outcomes will be monitored and evaluated annually.

1. Capture and band ~100-150 California quail off the wildlife area following the hunting season and relocate these on the Indian Dan and other Units as needed.
2. Survey hunting related public use through the hunter registration program on the Indian Dan, West Foster Creek, Central Ferry, Washburn Island and Bridgeport Bar Units to document hunting use and wildlife population trends.
3. Grow approximately 75 acres of irrigated grain on Bridgeport Bar and Washburn Island (wheat, barley, corn, millet etc.) and 30 acres of dryland wheat on the Indian Dan and West Foster Creek Units.
4. Maintain and irrigate about 50 acres of permanent nesting cover on Washburn Island. Evaluate 2008 seeding and need for additional seeding.
5. Plant about shrubs and trees as needed. Irrigate and maintain 60 acres of woody plantings.

6. Fill and maintain 24 bird feeders located throughout the area.
7. Maintain 11 gallinaceous guzzlers and 6 developed springs on the Indian Dan, Central Ferry and West Foster Creek Units as needed.
8. Service, repair, and maintain about 100 nest boxes and 50 goose nest structures on and in the vicinity of Wells Pool including twenty islands, the Bridgeport Bar, Okanogan River and Washburn Units. Replace nest structures and boxes as needed. Survey and map wood duck boxes.
9. Maintain 3 deer exclosures surrounding West Foster Creek shrub and tree plantings.
10. Release bio-control agents as needed to control knapweed, purple loosestrife and/or Dalmatian toadflax primarily in the West Foster and Central Ferry Canyon units.
11. Mow and treat weeds throughout the wildlife area as needed.
12. Maintain one mile of firebreaks on the West Foster Creek Unit and two miles on Bridgeport Bar.
13. Maintain 13 hunter registration booths, one office building, a shop and storage facilities. Maintain vehicles and equipment.
14. Survey goose nesting on and adjacent to Wells Pool (Lake Pateros). Coordinate with volunteers to survey kestrel and wood duck nesting.
15. Conduct fall wildlife population surveys on the Bridgeport Bar and Indian Dan Units using other WDFW staff and volunteers. Extent of survey is dependent on volunteer availability.
16. Cultivate about 10 acres on Bridgeport Bar to be planted to permanent cover in the spring of 2009.
17. Work with the Bureau of Land Management and volunteers to survey bald eagle winter roosts and American white pelican and double crested cormorant using Wells Pool.
18. Work with volunteers to increase monitoring of non-game species on the area. Emphasis will be placed on monitoring use of restored sites.
19. Experiment with forage kochia in firebreaks.
20. Prepare for restoration of about 70 acres of land on the West Foster Creek and Bridgeport Bar Units (RCO grant).

**Citizens Advisory Group (CAG) Input:**

The draft management plan update was mailed to the CAG for comment. No comments were received. Over time attendance at meetings has decreased substantially. Only two members attended the last meeting/field trip that was scheduled.
