DETERMINATION OF NONSIGNIFICANCE

Name of Proposal: FISH SCREENING PROJECTS ON SWAUK CREEK

Description of Proposal: The proposed fish screen installations are only necessary for a short-term basis. Currently, there is a storage feasibility study ongoing in the Swauk Creek drainage. Upon completion of the study, many points of diversion will likely be consolidated and/or eliminated. At that time, the two fish screens will be removed from the gravity ditches to be used at different locations that are yet to be determined.
