DETERMINATION OF NONSIGNIFICANCE (DNS)

Name of Proposal: BROWN- DITCH DREDGING

Description of Proposal: Existing ditch on property for spring runoff was filled with silt from November flooding. Ditch is approximately 200'- 300' long, varying from 2' to 6' wide. Proposal is to remove approximately 45-50 cubic yards of silt/soil, while ditch is dry. Materials will be spread on site in upland property location.
