DETERMINATION OF NONSIGNIFICANCE (DNS)

Name of Proposal: FALLS CREEK BRIDGE INSTALLATION AND STREAMBED

MAINTENANCE

Description of Proposal: Remove old stream-crossing culverts on low-volume forest road, and replace with 60' bridge. Realign road approaches, approximately 250' on each side of crossing. Remove accumulated gravel deposits in stream, approximately 150' above and below bridge site, totaling approximately 1,100 cubic yards during construction. Maintain stream bed elevation at site by removing up to 500 cubic yards additional material per year from 2007 through 2012. See attached "Falls Gravel Removal Plan" for details
