DETERMINATION OF NONSIGNIFICANCE (DNS)

Name of Proposal: SHILLAPOO VIEWING BLIND AND STORAGE SHED PROJECT

Description of Proposal: WDFW desires to provide wildlife viewing opportunities to the general public and also upgrade storage potential for Wildlife Area Equipment. The specific components of this project are:

- 1. Construct a 30-foot by 60-foot agricultural storage building with a fenced perimeter.
- 2. Construct a 90 square foot ADA accessible viewing blind.
- 3. Construct an associated gravel-parking area for public use.
- 4. Install an ADA accessible vault toilet and ADA parking space.
- 5. Replace existing gate and provide a turnaround area for firefighting equipment.
- 6. Install an interpretive sign near the viewing blind.
